- RESOLUTION NO. 2023-64: A RESOLUTION ESTABLISHING A PICK UP OF VOLUNTARY CONTRIBUTIONS THROUGH PAYROLL REDUCTION FOR THE PURCHASE SERVICE CREDIT FOR POLICE, AND DECLARING AN EMERGENCY. **- Adopted**
- RESOLUTION NO. 2023-65: A RESOLUTION ESTABLISHING A PICK UP OF VOLUNTARY CONTRIBUTIONS THROUGH PAYROLL REDUCTION FOR THE PURCHASE SERVICE CREDIT FOR FIRE, AND DECLARING AN EMERGENCY. **- Adopted**
